As Director/Proprietor/Partner/Principal Official (please choose as appropriate) of the above-named exporter, I hereby submit an application for a **Certificate of Origin Re-export** (Movement Confirmation) to cover the goods to be re-exported/re-exported from Hong Kong for the purpose of claiming tariff preferences under Chapter 3 (Rules of Origin) of the ASEAN-Hong Kong, China Free Trade Agreement. I hereby declare that:
  - (i) I am duly authorized to make and sign this declaration on behalf of the above-named exporting company/firm;
  - (ii) all the information given herein has been checked by me and is true;
  - (iii) the consignment described in this application were produced in the country/place provided in the box "Place of Origin of Goods" above and that they comply with the rules of origin as provided in Chapter 3 (Rules of Origin) of the ASEAN-Hong Kong, China Free Trade Agreement for the goods exported to the country/place provided in the "Destination" box above;
  - (iv) the consignment described in this application have not undergone / will not undergo any further processing in Hong Kong, except for repacking or logistics activities such as unloading, reloading, storing, or any other operations necessary to preserve them in good condition or to transport them to the importing Party;
  - (v) I have not applied to any other Issuing Authority for a Certificate of Origin in respect of the consignment described in this application; and
  - (vi) the attached Certificate of Origin (Form AHK) issued by the originating country/place has not been and will not be used to support any other applications for Movement Confirmation in Hong Kong.
- 2. I understand that authorized officers of Hong Kong Customs and Excise Department may enter the business and storage premises of my company / registered business / storage place of goods for the purpose of inspection of goods and documents and verification of information relating to the application. I undertake to permit and arrange such visits.
- 3. I understand that in accordance with Rule 10 of Annex 3-1 (Operational Certification Procedures) to Chapter 3 (Rules of Origin) of the ASEAN-Hong Kong, China Free Trade Agreement, the validity period of the Movement Confirmation issued will not exceed the validity period of the original Certificate of Origin (Form AHK). In this application, the original Certificate of Origin (Form AHK) will expire on \_\_\_\_\_\_\_\_ (one year from the date of issue). Hence, the Movement Confirmation, if issued, will expire on the same day.
- 4. I authorize The Hong Kong General Chamber of Commerce with which I have filed this application to disclose all or any of the information provided herein to the Hong Kong Customs and Excise Department or other government departments, or to any third parties in Hong Kong or elsewhere for the purpose of processing or verifying this application, for the implementation of the ASEAN-Hong Kong, China Free Trade Agreement, or when the disclosure is authorized or required by the laws.

## Warning:

The maximum penalty for making a false declaration in an application for the issue of a Certificate of Origin or for the substitution of goods in respect of a Certificate of Origin is \$500,000 and two years' imprisonment.

## Notes on Application for Movement Confirmation

- 1. This application and declaration must be completed personally by the director, the proprietor, a partner or principal official of the company exporting the goods.
- 2. The Movement Confirmation must contain relevant information from the original Certificate of Origin (Form AHK).
- 3. Please refer to the Certificate of Origin Circulars issued by the Trade and Industry Department from time to time for information on the application conditions of the Movement Confirmation when completing this application.
- 4. Any amendments to this form must be initialed and stamped by the respective applicant.
- 5. The duly completed application form and all supporting documents must be submitted to The Hong Kong General Chamber of Commerce at least two clear working days before exportation of goods. The declared goods will be available for inspection for not less than two clear working days before the departure of the shipment from Hong Kong.
- 6. Under the AHKFTA, the manufacturer and/or exporter applying for a Certificate of Origin (Form AHK) should keep its supporting records for application for not less than <u>three years</u> from the date of issuance of the Certificate of Origin (Form AHK) concerned. The same should apply to the intermediate exporter applying for the issuance of an MC.
