PRIVACY POLICY

This Privacy Policy explains, among other things, the types of personal data we collect and how we process and protect that data.

We shall keep your personal data confidential and shall ensure that our policies and practices with respect to the collection, use, retention, disclosure, transfer, security and access of your personal data comply with the Personal Data (Privacy) Ordinance (Cap.486 the Laws of the Hong Kong Special Administrative Region) (PDPDC), as amended from time to time.

Purpose of Collection and Use of Personal Data
