關於阿曼實施電子領事認證服務安排

根據阿曼領事館的通知，阿曼電子領事認證服務已於2026年5月14日在香港正式推出。由該日起，阿曼領事認證服務已全面改用電子印章，並已於2026年5月13日後停止使用傳統實體印花。

在新安排下，如申請人透過本會代辦阿曼領事認證，經本會簽發商事證明後，相關文件將會以電子方式掃描，並按阿曼領事館的程序以電子方式在文件上加蓋領事認證印章。

完成認證後，文件上將顯示阿曼領事館的電子印章、條碼及區塊鏈認證標誌。申請人或文件接收方可掃描文件上的條碼，核實已認證文件的真實性。

此項安排有助降低文件被偽造的風險，並提升認證文件的真實性及公信力。同時，全面改用電子印章後，亦可避免以往可能因實體印花短缺而影響認證安排的情況，使整體申辦及使用流程更為流暢方便。

申請人應留意，阿曼領事認證由阿曼領事館按其要求及程序處理；本會將繼續提供代辦領事認證服務，協助申請人按領事館要求提交文件。

Dear Oman Consulate Endorsement Applicants,

Electronic Consulate Endorsement Arrangement for Oman

According to the notification from the Oman Consulate, the electronic consulate endorsement service for Oman was officially launched in Hong Kong on 14 May 2026. From that date, Oman consulate endorsement services have fully adopted electronic stamps, and the use of traditional physical stamps ceased after 13 May 2026.

Under the new arrangement, if applicants arrange Oman consulate endorsement through HKGCC, after the Certificate of Documents is issued by HKGCC, the relevant document will be scanned electronically and the consulate endorsement stamp will be applied to the document electronically according to the procedures of the Oman Consulate.

Upon completion of the endorsement, the document will show the electronic stamp of the Oman Consulate, a barcode and a blockchain verification mark. Applicants or document recipients may scan the barcode on the document to verify the authenticity of the endorsed document.

This arrangement helps reduce the risk of document forgery and enhances the authenticity and credibility of endorsed documents. The full adoption of electronic stamps also helps avoid situations where endorsement may be affected by a shortage of physical stamps, making the overall application and use process smoother and more convenient.

Applicants should note that Oman consulate endorsement is handled by the Oman Consulate according to its requirements and procedures. HKGCC will continue to provide consulate endorsement handling service and assist applicants in submitting documents according to the requirements of the Oman Consulate.
